The Council for the Arts Art Block 2018 Festival is scheduled for April 19-21, 2018! The event will begin on Thursday with artists arriving and setting up their easels throughout our historic community. The Opening Reception will be held Friday evening, and the grand finale will be Saturday's Block event! This is an outside event on the Arts Council block, 826 New Bridge Street Jacksonville, located across from Jacksonville City Hall and Freedom Fountain. We are currently inviting vendors to reserve their spots for Saturday, April 21 from 10:00am to 4:00pm. We anticipate more vendor interest than last year which was most successful!

Food vendor fee is \$100.00 for a food truck space. Vendors must provide their own equipment, power and water. No pets allowed. No alcohol is allowed or sold. Vendors are required to clean up their area and leave it free of litter. If selling food, the food permits will be the responsibility of the vendor.

Vendors must send in applications to the Health Department NO later than March 31, 2018. Booth assignments will be distributed at check-in. All vendors must be set up and ready for health inspection by 8am. Vehicles must be moved from the street by 9:30am to the designated vendor parking area, and ready to sell by 10am. Break down time is 4pm, as the block will be re-opened to public transportation after 5:00pm.
